



DEA Level 3 Training

It is now compulsory that any property which is marketed for sale in England & Wales has to produce a Home Information Pack (HIP).

The HIP is made up of the following components:

- **Energy Performance Certificate**
- **Sellers information & index**
- **Local authority searches**
- **Drainage & water searches**
- **Land registry title & plan**
- **Leasehold information if applicable**

The Energy Performance Certificate (EPC) can only be carried out by a Level 3 qualified Domestic Energy Assessor or Home Inspector. This qualification is achieved through Rigmaden and our awarding body the ABBE.

How do you become qualified as a Domestic Energy Assessor (DEA)?

You do not have to have any previous experience in surveying or energy consultancy to enrol on the DEA course. You will have to complete 3 days training at any of our training centre locations. During your 3 days we will demonstrate to you how to survey houses for energy calculations and also how to use the RDSAP (reduced data standard assessment procedure) software. This software is what all assessors use to produce the Energy Performance Certificate (EPC).

Rigmaden will also take you out on the 3rd day to live properties for real hands on experience. By this time you will be energy assessing yourself.

Unfortunately, your qualification diploma is not obtained after 3 days with us. All candidates following their time with Rigmaden are then required to produce a portfolio of work. This will essentially be made up of 5 EPC's which you have to produce yourself.

There will be a requirement for further work which will complete your portfolio and demonstrate to us that you are able to carry out the tasks involved in energy assessment.

Finally, all candidates have to sit a 20 question multiple choice exam. This is a paper based exam where you have to answer 14 or more questions correctly in order to pass.

On successful completion you will be awarded your level 3 DEA diploma. Using this diploma you can then apply for accreditation to become a fully licensed DEA and begin working.

Frequently asked questions.....

How long does it take to become qualified?

This greatly depends on you. Once you have completed the 3 days training you then have to complete your portfolio of work. Most candidates working on very part time hours in their own time will complete the course in approximately 10 to 12 weeks whereas someone spending much more time will complete the course dramatically sooner. There is no time limit and every person differs.

What happens if I fail my exam?

Rigmaden will register you for your next exam date as soon as possible and you can sit this exam free of charge. A very high proportion of our candidates pass their exam first time.

The Energy Performance Certificate is just 1 part of the HIP. How can I supply the whole pack?

Rigmaden can provide you with additional training. This training will show you fully how you can produce all the components of the HIP pack. Not many DEA's will provide a full HIP pack so this could prove valuable to your services. Providing the full pack should gain you additional work and

higher remuneration. Talk to us if you want more information about this training.

Can Rigmaden provide me with work when I am qualified?

Where will I get my work from?

You will need to market yourself with Estate agents, HIP pack providers, solicitors and soon letting agents as all rental properties will fall under the new EU legislation.

Can I progress further after level 3?

Level 3 is a good starting point for people wanting to get into this industry. You may feel you want to progress further and upgrade to either of these qualifications:

Level 4 Home Inspector –

The HI course is available and will allow you to produce Home Condition Reports (HCR). The HCR is not mandatory and it is debatable whether or not this will ever become part of legislation. Many argue it will not. You may want to think long and hard before committing to this training. If clients are not required to have a HCR produced it is highly unlikely you will get any work providing them. If the HCR in the future does become a required document then you would simply contact us and upgrade your level 3 diploma by studying further. (Approximately 4 months)

Level 3 & 4 Non domestic energy assessment

Many candidates will find it a natural progression to upgrade to non domestic qualification. This will allow you to survey and assess commercial properties. The course however is much more demanding and intense than the domestic energy course learning and we will need to ask you some questions to evaluate your competence level before you enrol on this course.
